

**March 2025 “Whose Winnings Are Whose?” Social Media Promotion**

**OFFICIAL RULES:**

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) March 2025 “Whose Winnings Are Whose?” Social Media Promotion (“Promotion”) begins on Tuesday, March 4<sup>th</sup>, 2025 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, March 30<sup>th</sup>, 2025 at 11:59 p.m. ET (“Promotion Period”). During the Promotion Period, players will visit the “Whose Winnings Are Whose?” promotion website (<https://WhoseWinningsAreWhose.com>), where a visitor may participate in the web game and complete the entry form. The Promotion will include one (1) entry period and one (1) drawing at the conclusion of the entry period for a total of ten (10) winners, who will each receive ten (10) Max-A-Million scratch-off tickets (Game #985) (“Prize”). Estimated Retail Value (“ERV”) of each Prize is \$300. ERV of all Prizes in this Promotion is \$3,000.

The list of entrants, including full names and email addresses, will be exported at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified via email within one (1) week of the Draw Date.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number, and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act and the drawing procedures. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, Cactus Communications Inc., Spurrier Group, MDI Entertainment, LLC, BrkThru Digital, Preston CPA, and members of their respective households, are prohibited from participating in this Promotion.

3. HOW TO ENTER: There is a limit of one (1) eligible entry per person for the specified entry period during the Promotion. All entries must be submitted via the promotion website during the Drawing Entry Period to be eligible for the drawing.

Winners will be randomly selected from the following method of entry:

PROMOTION WEBSITE: Users may enter by completing the activity on the promotion website (<https://WhoseWinningsAreWhose.com>). After a visitor completes the game, the visitor may enter the Promotion by filling out the entry form fields with their name, email address, and phone number, and confirming they meet the eligibility requirements. A valid entry shall be defined as the first entry received per email address.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. WINNERS & PRIZE: Odds of winning in this drawing depend on the number of entries received for that drawing. Entries will be collected via qualified form submissions on the “Whose Winnings Are Whose?” promotion website. A list of entrants will be exported at the end of the Entry Period. Ten (10) winners will be randomly selected from the list of entries to receive a Prize, for a total ten (10) Promotion winners. Total Estimated Retail Value (“ERV”) of each Prize is \$300. Total ERV of all Prizes in this Promotion is \$3,000. Winners are subject to minimum Federal and State taxes and other State withholdings, as required by law. The NCEL will issue a W-2G form to Prize winners for Prize wins above \$599.

Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be contacted via the email provided upon entry. The Sponsor may also attempt to contact winners via the phone number provided upon entry, if no response is received to the email notification. If selected entrants do not respond to the email or phone notification directing them to contact the Sponsor within seventy-two (72) hours of initial notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor’s notification within the specified deadline but fails to provide their full name, North Carolina mailing address, birthdate, phone number, and email address to the Sponsor’s notification, they may be disqualified, in the Sponsor’s discretion, and the prize will be awarded to an alternate.

Selected entrants must present a valid, government-issued photo ID matching the name of the winner to claim the Prize at a Regional Office.

The Promotion is not sponsored, endorsed, administered by, or associated with Facebook or Instagram.
